2. Presentation on Journal Subscription Prices and the Libraries' Budget [Associate Dean of Libraries Dan Mack]

Questions asked/issues raised

- The Libraries purchase a 'package' from Elsevier: Science Direct. It is possible to choose title by title but this is time consuming and requires campus-wide faculty input.

- Renegotiations begin in January for several Big Deals. More information to come.
- Do units on campus contribute directly to the budget depending on their income?
 - The four units providing funds are listed on Dan's slide [slide 2]
- Impact of Open Access on the Global South?
 - Incorrect perception of only positive outcomes
 - Disruptive to e.g. in Latin America - the Latin American publishing community has an OA policy but this is undermined by the commercial publishers used by North America, UK and EU

 - Possible topic for a Library sponsored Interdisciplinary Dialogue <https://www.lib.umd.edu/research/events/dialogue>
- Researchers are often forced to publish in expensive, but high impact/prestigious, journals e.g. *Nature*, as a condition of their grant funding or as part of tenure/promotion procedures

- Dan will provide a bibliography on this topic at a forthcoming ULC meeting

3. Continue our multi-session discussion about open scholarship, open science, open access

... with a focus during this meeting on:

- Key takeaways from NSF Updates on Public Access Policy as related to recent OSTP memo
 - ULC members received a transcript of the recent webinar. Distilled main points will be forthcoming. Self archiving will be permitted. UMD's Open Access Policy aligns with this
 - Requirement to make data publicly available. The Divisions of IT and Research, and the Libraries are coordinating on this issue. A campus-wide survey will be released in early 2023 to gauge type of data and size files to inform next steps
- PACT working on draft resolution derived from NASEM HELIOS
[UMD PACT](#) is sponsored by ULC. Ongoing work includes this draft resolution; it will be workshopped and shared across campus in 2023. Commitment to begin a dialogue.
- TOME [Toward an Open Monograph Ecosystem]
[UMD TOME](#) pilot extended to a second year. TOME@UMD is led by the University Libraries in partnership with the Office of the Senior Vice President and Provost, and the College of Arts and Humanities. Three open access long-form books written by UMD faculty have been published in the first year. Continuation of the national TOME group is expected to be announced soon.
